A former biology teacher and principal, Dr. Tommy Chang is a fearless advocate for education equity and for fostering safe, welcoming, and sustaining learning environments for all students, including immigrants, LGBTQ youth, court-involved students, and homeless youth. He has earned national recognition as an education leader for his experiences in Boston and Los Angeles.

Dr. Chang reflects, "Every student deserves the opportunity to achieve the greatness within them. Unfortunately, there are clear opportunity gaps that most affect the youth that we have marginalized. I am honored to join an organization that is tackling issues of racial and systemic oppression heads-on by supporting schools and school systems to deliver a transformative educational experience for youth across the country."

As Superintendent of Boston Public schools, Dr. Chang served 57,000 students in 125 schools. During his tenure, graduation rates increased, dropout rates decreased, and the school district had more high-performing schools than ever before. Previously as the Local Instructional Superintendent, Intensive Support & Innovation Center (ISIC) at the Los Angeles Unified School District, Dr. Chang oversaw 135 schools and approximately 95,000 students. In this role, he focused on school turnaround efforts and supported innovative school models across the school district.

Fu shares, "Tommy's leadership is an incredible model of fighting for equity in real ways. He is unafraid of leading with his own identity, and as a system leader, he has been thoughtful about creating both belonging and academically-challenging opportunities for students. I'm thrilled about the experience and perspective he will bring to our work."

Dr. Chang holds an Ed.D. in Educational Leadership from Loyola Marymount University, M.Ed. from the Principals Leadership Institute and Teachers Education Program at UCLA and a

bachelor's degree from the University of Pennsylvania.
